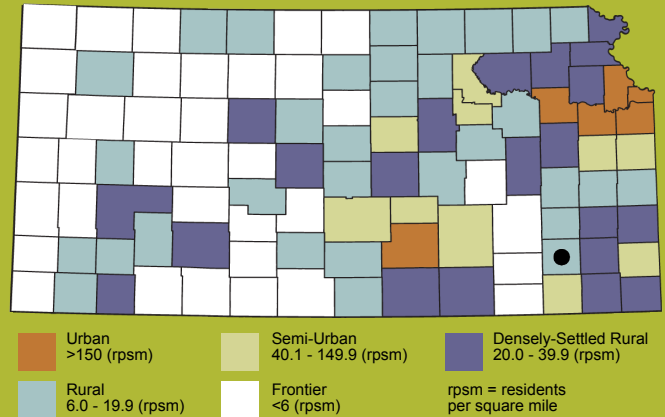

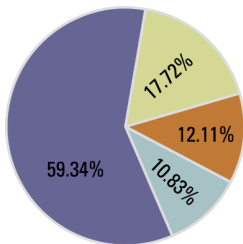

Poverty status of Kansas children under 18.

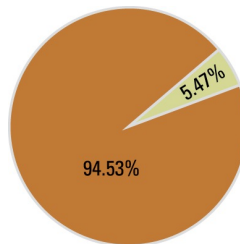

Health insurance status of Kansas children under 18.

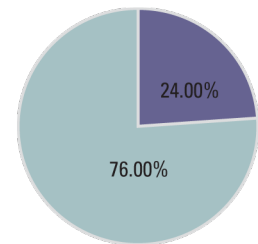


Percent of children without insurance Trend -0.58%
